#### Migration & Refugee Services (MRS)

In cooperation with the U.S. Department of State and the Arizona Office of Refugee Resettlement, MRS welcomes families who have legally entered the United States and have escaped persecution in their home countries.

MRS provides resettlement services, which includes case management, links to employment, job readiness training for adults, transportation, housing, short-term financial assistance, English as Second Language class for adults, and school registration for children.

#### **Immigrant Survivors Legal Assistance**

Immigrants who have been victimized in the United States or abroad are helped through the Immigrant Survivors Legal Assistance (ISLA) program, to make themselves whole and obtain legal status in the United States. Through a grant with the US Department of Justice Office of Violence Against Women, ISLA attorneys and paralegals work with immigrant survivors of domestic violence and sexual assault on their immigration cases.

## **IRC** Programs in Tucson

- **Resettlement:** Meeting the basic needs for food, shelter and legal rights in the early, critical stages of resettlement.
- **Economic Empowerment:** Protecting, supporting and improving household livelihoods and financial security.
- **Community Integration and Development:** Strengthening communities and preparing individuals to participate fully in American society.
- Health and Wellness: Promoting wellness and ensuring access to healthcare services that address physical and psychological needs. For survivors of torture, services include in-home well-being promotion, individual and group psychotherapy, including alternative therapies, and intensive case management.
- **Protection:** Promoting durable solutions and ensuring life-saving protection of vulnerable populations.

IRC's Immigration Services directly assists clients with the processing and filing of applications for a variety of immigration benefits:

- The IRC assists refugees and immigrants in obtaining Lawful Permanent Resident Status ("Green Card")
- We help qualified Lawful Permanent Residents apply for citizenship
- We help reunite refugee and asylee families who have been separated by war and conflict, and assist immigrants and U.S. citizens to petition for family members to come to the U.S.
- We support qualified low-income applicants in obtaining fee waivers from certain USCIS application fees
- We assist with applications for Deferred Action for Childhood Arrivals while supporting Comprehensive Immigration Reform to provide a pathway to citizenship for undocumented immigrants
- We assist refugees, immigrants, and other qualified individuals with a range of other routine immigration matters, such as employment authorization, travel documents and document replacement
